Dear Exhibitors,

Please read the premium information carefully and make sure you fill out your entry forms correctly, completely and legibly and send in the correct fees for the entry. DO NOT RISK HAVING YOUR ENTRY REFUSED BECAUSE YOU DID NOT FILL IT OUT PROPERLY. AKC is pushing Trial Secretaries to accept only valid entries. Remember, an entry not completely filled out and including the back agreement page and the correct fees is not a valid entry.

As a Trial Secretary for 20+ trials I have found that a surprising number of exhibitors, including experienced ones, send in incomplete entries or forget what dogs and classes they have entered. Double check your entries before mailing them. The following are the most common offenses:

- Sent without the AKC agreement attached to the entry.
- Missing information--including (believe it or not) breed, AKC number, dog's AKC or call name, classes and jump height.
- Unreadable
- Unsigned
- Incorrect payment (make all checks payable to P.V.B.S.C.)
- No copy of the jump height card
- Entering Division A of Regular Standard Novice or Regular JWW Novice when the dog or handler has earned any AKC agility title.
